### **Agreement:**

This agreement is made between Squaw Valley, Alpine Meadows, and the corporate representative signing above.

### **Valid Dates:**

- ❖ The lift tickets are valid from opening day through close of the 2011/2012 season only at both Squaw Valley and Alpine Meadows. Tickets are direct to lift tickets and may not be used with any other coupon or discount program.
- ❖ Closing dates vary from year to year. Please check with Squaw Valley or Alpine Meadows for a projected closing date.

### **Price: Before Dec. 1<sup>st</sup>, 2011**

- ❖ Adult (ages 23-64): \$76
- ❖ Young Adult (ages 13-22): \$58
- ❖ Child (ages 5-12): \$29

### **Price: After Dec. 1<sup>st</sup>, 2011**

- ❖ Adult (ages 23-64): \$78
- ❖ Young Adult (ages 13-22): \$60
- ❖ Child (ages 5-12): \$31

### **No Resale**

- ❖ Tickets may not be resold on Squaw Valley or Alpine Meadows property's or premises.
- ❖ Squaw Valley and Alpine Meadows are not responsible for any tickets lost, stolen, or destroyed.

### **If Your Returning Squaw Valley or Alpine Meadows Tickets With Your Order :**

- ❖ The minimum ticket order is determined by how many tickets you are returning. You only have to purchase the amount you are returning. (Ex: You are returning 12 tickets; you only have to purchase at least 12 tickets).
- ❖ You may purchase more tickets than you're returning, but to get into the "new program" (stated below) you will have to purchase the minimum of 50 new tickets on top of any tickets you are returning.
- ❖ Tickets not used at the end of the season may be held onto for a credit towards the next year's purchase of corporate tickets.

### **New Orders of 50 :**

- ❖ Minimum ticket order is 50 tickets, thereafter they can be purchased in blocks of 25. You will receive 1 complimentary ticket with every 25 new tickets purchased. Complimentary tickets must be used the year they are issued and cannot be turned in for a refund.
- ❖ **Unused tickets must be returned before June 15<sup>th</sup>, 2012 for a FULL REFUND or can be held onto for a credit towards the purchase of the 2012/2012 Corporate ticket order.**
- ❖ To receive a refund, unused tickets must be returned via the company outlet that they were sold through. Exchanges or refunds from individuals to Squaw Valley or Alpine Meadows will not be accepted.
- ❖ The lift ticket is non-refundable and has no cash value to the individual.

### **Exchange Options:**

- ❖ One Adult corporate ticket may be exchanged for an adult/ young adult 1<sup>st</sup> Time Skier/ Snowboarder Package with no additional fee at Squaw Valley or Alpine Meadows. Packages include an all day beginner lift ticket valid only at beginner lifts, an all day lesson, and a ski/snowboard rental.
- ❖ Exchange 1 Adult corporate ticket for a \$76 credit towards a Squaw Kids or Alpine Kids package.
- ❖ Being a corporate ticket holder you are eligible for a discount when you stay at The Village at Squaw Valley. Call our reservation center at 888-767-1907 to check availability and to make a reservation. Ask for the Corporate Ticket Program discount.
